## CDAS MEMBER RESPONSIBILITIES - Appendix E

1. Member must be in good standing with CDAS.
  2. Member will abide by all CDAS rules and policies as outlined in the CDAS bylaws & in the CDAS Park Rules & Policies Appendix F.
  3. Member can purchase an annual riding pass at a rate determined from time to time by the CDAS Board of Directors.
  4. Member acknowledges receipt of CDAS Park Rules & Policies Appendix F.
  5. Member will work with other users in a cooperative and tolerant manner for the benefit and betterment of the Park and it's members.
  6. Any conflicts should be addressed with the Operations Manager and will be brought before the CDAS Board for resolution, if necessary.
  7. Any use of the park must be pre-approved by the Operations Manager or designate. A parent or guardian must accompany individuals under the age of 18. No under aged individual will be allowed access to the park alone.
  8. Member will refer to and follow all postings on the event calendars.
  9. Member will ensure that:
    - a. All litter & manure is picked up and placed in the proper receptacles
    - b. All gates are secured and locked if necessary
    - c. All maintenance or clean-up is done as directed by the CDAS
- At CDAS discretion, a minimum fee of \$50 can be charged to the member or group in the event clean-up is not completed**
10. Member will ensure that they conduct themselves in a manner supporting the multi-discipline aims & goals of the CDAS as a whole at all times.
  11. Approval from the Board and the proper permits must be obtained for use of alcohol on the CDAS grounds. Drugs and illegal activities are not permitted.
  12. Member will provide volunteer help for CDAS fundraising activities.
  13. Member privileges can be revoked for any breach of the rules & policies by the CDAS.

**THE COCHRANE & DISTRICT AGRICULTURAL SOCIETY** is committed to the improvement in agriculture, horticulture, home making and the quality of life in the agricultural community by:

1. Any permanent structure in the Park becomes property of the CDAS.
2. The CDAS has the right to refuse entry to the park to any persons or groups.
3. The CDAS will attempt to give moral, financial and preferential support to groups that enhance agricultural activities.
4. The CDAS will control all activities in the Park in order to ensure coordination.
5. The Park and its facilities will be made available for outside rentals.
6. The CDAS has the right to refuse or restrict entry to any group or person who abuses or damages the Park or any equipment belonging to the CDAS. Entry may also be refused or restricted for behavior in an unseemly, belligerent, or inhumane manner; or non-compliance with the rules and regulations of the CDAS.
